- 2. Should write correct 10 Digit mobile number. Mobile number provided should not be registered in **DO NOT CALL** List .
- Email id should be written with correct domain name. (e.g. ***@yahoo.com;***@gmail.com)
- 4. Create a separate folder for all SSL emails in your Mail box. This will facilitate you in accessing all the related emails from SSL for your future reference.
